The wonder and beauty of the Model T Ford is not only its durability, but also its longevity. Model T's can not only participate in MTFCA and MTFCI events and tours, but also the Glidden Tour, many AACA and VMCCA events, plus, if your T is old enough, the Horseless Carriage Club of America.

Take the Glidden Tour as a case in point. We recently participated in the Glidden Tour in Pennsylvania. Of the 112 Pre-War cars registered, 45 were Fords. And of those 45, 6 were model T's. To qualify for the Glidden Trophy, your car had to be 1913 or older, and complete the run every day. Of the 9 cars eligible for this great honor, 4 were Model T's! It rained every day of the tour, all week long! We got soaked in an open car. And by the end of the second day, only 2 cars were left qualified for the Glidden Trophy. By Friday, not a one was qualified - for the first time in the history of the Glidden Tour! So the representatives of the AAA, AACA, and VMCA put their heads together and awarded the trophy to the car that made it the farthest.

It does give the appearance of having been registered and driven in Egypt! You just never know about the Model T!

### The Jun of Driving an Old Car: License and Insurance, Please




### In Memoriam

### MINUTES OF THE BOARD OF DIRECTORS OF THE MODEL T FORD CLUB OF GREATER ST. LOUIS FRIDAY, SEPTEMBER 13, 2024

The meeting was called to order at 6:30 pm by President Steven Williams. Members present were President Steven Williams, Vice President Kent Gilbane, Treasurer Bonnie Dattoli, Secretary Ruth Baker, Directors Daniel Mullis, Keith Sanders, Jerry Ellerbeck, Sr., Jerry Ellerbeck, Jr., Don Spaeth, and Stephen Heatherly.

Minutes of the June 14, 2024 Directors Meeting were read. Kent Gilbane made the motion to approve the minutes; the motion was seconded by Jerry Ellerbeck, Jr., and carried unanimously, with no objections.

Treasurer Bonnie Dattoli gave an update on the end of the 2023-2024 fiscal year and stated that 85.82% of the 2023-2024 budget had been spent. Following is the update for the 2024-2025 fiscal year to date: Bonnie Dattoli stated that \$2,000.00 had been moved from the Checking Account to the Money Market Account. President Steven Williams gave a review of the dues structure for this year. National members will begin paying \$20.00 in local dues, effective July 1. Local dues for non-national members will be \$35.00 per year. Local dues for those non-national members who have already paid the \$25.00 and now pay the remaining \$10.00 will be paid up until July 1, 2025.

There was a discussion about a request of Diann Rhoads who paid \$20.00 to have the Occasional printed and mailed to her in regard to the printing and postage expense in mailing the Occasional, and although the \$20.00 paid will not fully cover the costs, Kent Gilbane made a motion that the Club accept Diann's \$20.00 because of her long-time involvement. The motion was seconded by Keith Sanders and carried unanimously.

President Steven Williams reminded that the Christmas Banquet will be on December 7 at Gianino's on Telegraph.

There was a comment that because of the number of new members in the Club, perhaps these new members should have a chance to buy Club jackets. Sam Atkinson will be asked if there is a minimum requirement.

This year the October Director's meeting and Membership meeting will be held on October 11. The Fall tour will be on October 12, and the Chili Cookoff will be on the 13th. There was discussion about going forward if this will be acceptable, and the consensus was to leave these dates as scheduled.

Bonnie Dattoli discussed the payment of income taxes for the year, and she explained income tax credits, net operating losses, and payments due to Missouri and Illinois.

President Steven Williams read a thank you from Myrna Schild for the support and donation to the VFW. There was a thank you from the Model T Museum in memory of David Koste, Sr. and a nice note from Linda Koste, Flo Reichardt's daughter. A thank you was received from St. Jude for the \$50.00 donation in memory of Steven Thum's mother, Marlis Thum.

It was announced that an Audit Committee needs to be appointed to review the records of the fiscal 2023 2024 year.

The Nomination Committee is comprised of Bob Grincewich, Daniel Mullis and Jenny Sanders. Jerry Ellerbeck, Jr. said he will be a candidate for election for another term.

There being no further business, at 7:08 p.m., Kent Gilbane made the motion to adjourn. The motion was seconded by Don Spaeth and carried unanimously. The meeting adjourned at 7:08 p.m.

### MINUTES OF THE MEMBERSHIP MEETING OF THE MODEL T FORD CLUB OF GREATER ST. LOUIS FRIDAY, SEPTEMBER 13, 2024

The meeting was called to order at 8:01 p.m. by President Steven Williams. New members, Jack Williams and Pat who own a 1925 Model T coupe and Char Mason who owns a 1925 Model T were introduced. Jerry Ellerbeck, Sr. also introduced his friend, Pat.

Minutes were read from the August 9, 2024 meeting. Bill Tabor made the motion to approve the minutes. The motion was seconded by Scott Francis and carried unanimously, without objection. Treasurer Bonnie Dattoli gave the treasurer's report. Sam Atkinson made the motion to approve the Treasurer's Report. The motion was seconded by Keith Sanders and carried unanimously, with no objections.

Jerry Ellerbeck, Jr. reported that the video library is available and to see him if anyone wants to check out anything. Don Spaeth reported that the library is available. ### OCCASIONAL AND DUES CHANGES!
